TERMS AND CONDITIONS OF THE APPOINTMENT

4. The appointment is on contractual basis and is purely temporary. The tenure of posting shall be for one year initially likely to be extended for further phases of one year each subject to satisfactory performance report and institutional requirements. The post is likely to be terminated as soon as a faculty joins after regular selection via promotion or otherwise. The posting is also likely to be terminated without any reason by a 3 month's advance notice by either party. The posting shall be terminated at any time on grounds of misconduct or unsatisfactory performance.
5. The appointee cannot place any claim for regularisation of the appointment.
6. The Contractual employees shall get remuneration as under as per notification by the state government:

7. The candidates on selection must submit an agreement in prescribed bond format at the time of joining at the institution.
8. The appointee shall perform the duties as assigned to him or her within the purview of the post. The authorities may also assign extra tasks as and when required.
9. Candidates with eligibility of a higher post may be preferred for a particular vacancy subject to willingness of the candidate for the same. An appointee in a higher rank may also be offered to hold a post of lower rank in case of administrative exigencies and institutional need subject to agreement by the candidate to that effect.
10. The appointee is entitled for leave as admissible by the state govt. rules for such appointments.
11. Residential accommodation may be provided subject to availability and seniority.

ELIGIBILITY

12. The detailed eligibility in terms of qualifying degree, teaching experience and publications is given in the table below. Equivalent DNB degree is acceptable as per rule. Teaching experience in higher rank shall compensate for the experience required in lower ranks.
13. The eligibility cut off date shall be the date of Walk-in-Interview.
14. The candidates working as Assistant Professor/ Associate Professor/Professor in any of the Govt. Medical College of Odisha or VIMSAR are not eligible to apply.
15. Candidates working on contractual basis under other Odisha state govt. services may apply under intimation to the employer, but they shall only be allowed to join after they resign from the present post with relieve order.
16. The qualifications must have been validly registered in a State or Indian Medical Register.
17. The candidate must be a citizen of India.
18. The candidate should not have been convicted by any Court of Law.
19. A candidate must be below **69 years of age**.
20. The candidate must have good moral character.
21. The candidate must have good physical and mental condition so that there is no interference in due discharge of his/her duties as an officer of the institute. A candidate who after such medical examination as the institute may prescribe if not found to satisfy these requirements will not be appointed.
22. Reservation policy shall not apply since the posts are temporary.

APPLICATION AND SELECTION

25. Application forms **NEED NOT** be sent in advance to the institute.
26. A **DD** for **INR 2500** only towards application fees payable to '**Dean, VIMSAR**' at **SBI-Burla** must be enclosed with the application form. The fees is not refundable anyhow.
27. Candidates applying for multiple disciplines shall have to submit separate application forms with separate application fees.
28. The candidate must report at the Institute as per programme schedule above. No representation shall be allowed. Candidates reporting late shall not be entertained. Any query as regards documents must be complied then and there otherwise the candidature is likely to be rejected.
29. Candidates employed in Government and Private sectors must apply with due intimation to the employer so that clarity is spelled out at the time of personal interview as regard relieving conditions from the previous employer.
30. No TA/DA will be given to the candidate for the selection or joining.
31. In case any information or declaration submitted by the candidate is found to be false, his/her candidature is liable for cancellation at any stage during selection or after appointment.
32. Result shall be published in the institute website after the selection process is over and the select list is duly approved by authorities of the institute. Appointment order will be issued to selected candidates via e-mail thereafter. The waitlisted candidates may be empanelled for subsequent appointments as per institutional needs. Candidates failing to join within the permitted joining period shall forfeit their candidature.
