In pursuance of G.O. No.5790/H/dt.09.03.2011 and G.O.No.23609/H/dt.06.09.2014, applications in prescribed formats are invited from eligible candidates for filling up various vacant faculty positions in different Departments of Veer Surendra Sai Institute of Medical Sciences & Research on contractual basis. The appointment shall be subject to formal state government approval. The engagement shall be purely temporary and renewable on year to year basis subject to satisfactory performance. The engagement may be terminated with one month notice from either party or without notice when regular posting is done to fill up the post.

REMUNERATION:

The candidates shall be entitled for a consolidated monthly remuneration of Rs. 35,000 for Assistant Professor, Rs. 55,000 for Associate Professor and Rs. 80,000 for Professor or as decided by the Government from time to time; the amounts are likely to be revised. Doctors working under Odisha State Government and satisfying the eligibility criteria can apply and shall be entitled for remuneration equivalent to their present salary. They shall furnish an undertaking to the effect that they shall not claim any financial benefit at par with the medical college teachers and regular appointment in the said post.

VACANCY:

The vacancies are provisional and subject to change. Posts may not be filled in case of non-availability suitable candidates or any other administrative exigencies.

RESERVATION:

The prevalent reservation policy of the state government shall be applicable. In case of non-availability of suitable candidates in any reserved category the posts shall be filled up from non-reserved category. Reservation shall not be applicable for candidates who are not Permanent Resident /Native of the State of Odisha.

AGE:

The cut off date for age calculation shall be 1st October 2016. For Assistant Professors, the candidate must not be above 45 years of age. The upper age limit will be relaxed up to five years in case of Women, ST, SC, SEBC and Odisha State Government servants and up to 10 years for Physically Challenged candidates. For Associate Professors and Professors the age limit shall be maximum 64 years.

ELIGIBILITY:

1. The candidate must be a citizen of India.
2. The candidate should not have been convicted by any Court of Law.
3. The candidate must possess a basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956). They must also be registered in a State Medical Register or Indian Medical Register.
4. A postgraduate qualification e.g. MD/MS or a recognized qualification equivalent thereto in the relevant /respective discipline as applicable by rule. Candidate possessing DNB degree shall require additional teaching experience in the concerned subject as per MCI rule. For super-specialty disciplines DM/ MCH degree in concerned discipline shall be mandatory.
5. In case of non-availability of MS/MD candidates M.Sc. qualified candidates as prescribed by the MCI will be appointed in the Department of Anatomy, Physiology, Pharmacology and Microbiology to the extent of 30% and in the Department Bio-Chemistry to the extent of 50% of the total number of posts.
6. Teaching experience of minimum of 3 years as Senior Resident/Tutor in the concerned discipline in any MCI recognised institute is a must for Assistant Professors.
7. Associate Professors must have an additional teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI recognised institute. Professors must have an additional teaching experience of minimum 3 years as Associate Professor in the concerned discipline in any MCI recognised institute.
8. For Associate Professors and Professors in Superspecialty disciplines the minimum teaching experience shall be reduced by one year.
9. Research publications will carry weightage as per rule. An aptitude for teaching and research will be desirable.
10. The eligibility as on the date of interview shall be considered.

APPLICATION PROCESS

1. The application form is available on institute website www.vimsar.ac.in.
2. Candidates applying for multiple disciplines shall have to submit separate application forms with separate application fees.
3. The applicant should submit duly filled application form along with self-attested photocopies of their proof of date of birth, eligibility qualification, mark-sheets, degrees, experience certificate and other relevant testimonials.
