In pursuance of G.O. No.7763/H& FW/dt.18.03.2017, applications in prescribed formats are invited from eligible candidates for filling up various vacant faculty positions in different disciplines of Veer Surendra Sai Institute of Medical Sciences & Research on deputation basis. The appointment shall be subject to formal state government approval. **VACANCY:**

TERMS OF REFERENCE:

The following terms of reference have been fixed by the state government for the appointment of faculties as per vacancy.

- 1. Candidates working in Odisha Medical Health Services [OMHS] cadre/Public Sector Undertaking/other State Governments/ Central Government in different disciplines may apply.
- 2. There will be no reservation policy as the posts are filled up temporarily and as they could not be filled up by the OPSC.
- 3. The applicants will obtain permission from the Cadre Controlling Authority before submitting their applications. Those who are serving under OMHS cadre shall apply directly.
- 4. The salary will be paid to the Doctors posted on the basis of exercising option for availing the salary of existing scale or scale for the post.
- 5. Those selected from OMHS cadre will be allowed with the protection of their existing pay in the parent cadre and the higher of the GP/AGP of the post they join in. The service conditions will continue for being a State Government employee. At the time of reversion back to the respective parent cadre, their pay will be fixed as per Note 2 of Rule 79 (c) i.e. the presumptive pay in the parent post and will be considered towards increment for the period worked as a faculty. To read otherwise, for all purposes they will be entitled to salary and allowances of the post they hold for the period they are put under deputation/deployment.
- 6. The pay of the employees working in CGHS/ other State Governments/PSUs will be protected on production of LPC.

- 7. The postings made will be purely temporary and shall be till such time when the post is filled up by regular selection. The candidates cannot claim their right to continue in the post on the basis of such appointment. In view of anticipation of claim by the faculties, they will give an undertaking to this effect.
- 8. The terms and conditions as prescribed in the Odisha Service Code will be sanctioned by the Government in H & FW Department.
- 9. In case the incumbent while on deputation/ deployment retires/dies/resign/removed, the pay which one would have been entitled had he continued in the original post shall be treated as last pay for pension determination u/r 2 of Pension Rules 1992.
- 10. Those selected for the post from outside the OMHS cadre will be under deputation on Foreign Service terms and conditions. They will be guided by the standard terms of deputation as per FD OM dtd.02.12.1962.
- 11. Direct candidates can also apply; however, their application status, selection, pay and other terms and conditions of service shall be as sanctioned by the state government from time to time and the institute authorities in no way shall be held accountable in term of any legal, administrative or judicial hurdle in that context at any point of time.
- 12. 'Odisha Medical Education Service [OMES] cadre candidates' or 'OMHS cadre candidates under deputation/deployment against a vacant OMES cadre post in any of the govt. Medical colleges in the state' may also apply provided they enclose with the application one 'no objection certificate' from the cadre controlling authority, i.e. the state government failing which their candidature shall be rejected forthwith.
- 13. The candidates who have participated in the selection of faculty in connection with Advt. No. VIMSAR-F-2016[1] need not apply again. However each one of them is required to submit one undertaking [as per format annexed herewith] to the effect that he/she is willing to be part of this selection process vis-a-vis the revised terms of references notified herewith and is agreeing to the possible alteration in the merit list hereafter. Those who fail to submit such undertaking shall be deemed to have withdrawn themselves from the selection process leading to deletion of their names from the applicant list altogether. Those candidates who have applied earlier, but did not turn up for document verification and personal interview have to apply afresh with due process and application fee.

ELIGIBILITY:

- 1. The candidate must be a citizen of India.
- 2. The candidate should not have been convicted by any Court of Law.
- 3. The upper limit for age limit shall be 62 years as on the 1st of January 2017 for all applicants.
- 4. The candidate must possess a basic University or equivalent qualification included in any one of the Schedules to the Indian Medical Council Act, 1956 (102 of 1956). They must also be registered in a State/Indian Medical Register.
- 5. A postgraduate qualification e.g. MD/MS or a recognized qualification equivalent thereto in the relevant discipline as applicable by rule. Candidate possessing DNB degree shall require additional teaching experience in the concerned subject as per MCI rule. For super-specialty disciplines DM/ MCH degree in concerned discipline shall be mandatory.
- 6. In case of non-availability of MD/MS/DNB candidates, M.Sc. qualified candidates as prescribed by the MCI will be appointed in the Department of Anatomy, Physiology, Pharmacology and Microbiology to the extent of 30% and in the Department Bio-Chemistry to the extent of 50% of the departmental post strength.
- 7. Teaching experience of minimum of 3 years as Senior Resident/Tutor in the concerned discipline in any MCI recognised institute is a must for Assistant Professors.
- 8. Associate Professors must have an additional teaching experience of minimum 4 years as Assistant Professor in the concerned discipline in any MCI recognised institute. Professors must have an

additional teaching experience of minimum 3 years as Associate Professor in the concerned discipline in any MCI recognised institute. For Associate Professors and Professors in Superspeciality disciplines the minimum teaching experience shall be reduced by one year. Research publications will carry weightage as per rule.

- 9. An aptitude for teaching and research will be desirable for all candidates.
- 10. The eligibility as on the date of interview shall only be considered.

APPLICATION PROCESS

- 1. The application form and the format for undertaking are available on institute website www.vimsar.ac.in.
- 2. Candidates applying for multiple disciplines shall have to submit separate application forms with separate application fees.
- 3. The applicant should submit duly filled application form along with the requisite enclosures.
- 4. Complete Application/Undertaking within an envelope superscribed 'Advt-VIMSAR-F-2016-17[1A]' should reach the 'DEAN AND PRINCIPAL, VIMSAR, AYURVIHAR, BURLA-768017' on/or before the last date of application by Registered/Speed Post only.
- 5. The candidate must submit a **Bank Draft of Rs. 1000**/- only as processing fee in favour of '**Dean & Principal, VSS Medical College'** payable at '**SBI, Burla**, which is non-refundable in any case.
- 6. Applications incomplete in any aspect or received late shall be rejected. The institute shall not be responsible for postal delay.
- 7. Candidates who have already applied vide advt.no.VIMSAR-F-2016[1] need to submit one undertaking as per format annexed herewith within the last date of submission of the application form. They need not enclose any application fee. However, those candidates who had applied earlier, but did not turn up for document verification and personal interview have to apply afresh with processing fee.
- 8. No TA/DA will be given to the candidate if called for interview.
- 9. In case any candidate is found to have provided a false information or certificate, or is found to have withheld or concealed any information, his /her application shall be rejected and the appointment will be cancelled as the case may be besides disciplinary/legal action as deemed proper.
- 10. Canvassing in any form and /or bringing in any influence will be treated as disqualification.
- 11. The Competent Authority reserves the right to reject all or any application without assigning any reason. The Competent Authority reserves the right of any amendment, cancellation and changes to this advertisement as a whole or in part without assigning any reason or giving notice. Corrigendum if any and the Notice for Interview shall be published in the institute website only. The decision of the competent authority regarding selection of candidates will be final.

SELECTION PROCESS

- 1. The Selection Committee constituted shall conduct the selection based on career marks and/or aptitude for teaching and research which shall be evaluated during personal interview.
- 2. The Institute reserves the right to restrict the number of candidates for interview to a reasonable limit on the basis of qualifications and experience higher than the minimum prescribed in the advertisement besides other academic achievements.
