- 1. Applications in the prescribed format are invited from eligible candidates for the posts of Senior Residents/Tutors in the following disciplines at Veer Surendra Sai Institute of Medical Sciences & Research. The engagement shall be purely temporary and renewable on year to year basis for a maximum period of three years subject to satisfactory performance. The in-service departmental candidates will be entitled for salary and the direct candidates will be paid remuneration of Rs.50,000/- (Rupees Fifty Thousand only) per month or as decided by the government. The posts are non-practicing.
- **2. VACANCY:** The vacancy position below is tentative and subject to change on the basis of administrative exigencies at the discretion of the authorities.

Anatomy (1), Biochemistry(1), Physiology (3), FMT(1), Pharmacology (2), Pathology(3), Microbiology(1), Anesthesiology (11), Pulmonary Medicine(1), Dentistry (1), General Medicine (3), Orthopedics (3), Ophthalmology(1), Psychiatry (2), General Surgery (7), Dermatology(1), Radiodiagnosis (5), Cardiology (3), Neurosurgery(1), Urology(1), Neurology(1).

3. RESERVATION:

The prevalent reservation policy of the state government will be applicable. In case of non availability of suitable candidates in any reserved category the same post will be filled up from the unreserved category.

4. AGE:

The candidate must not be above 40 years of age as on 1st January' 2017. The upper age limit will be relaxed up to 5 years in case of Women/ST/SC, 3 years for SEBC and 10 years for Physically Challenged candidates. The same candidate cannot avail relaxation on more than one criterion simultaneously.

5. QUALIFICATION:

- a. A candidate must possess a MD/MS/MDS degree in concerned discipline for Senior Resident post in clinical departments of broad specialties; In superspeciality departments (Neurosurgery/ Genitourinary Surgery/Nephrology/Neurology/Cardiology) DM/MCh degree in concerned discipline is required failing which relevant MD/MS degree holders as per MCI rules will be considered. For Transfusion Medicine MD(Transfusion Medicine/ MD(Pathology) is required. A candidate with one superspeciality degree will not be eligible for other superspeciality disciplines.
- b. In case of Pre/Paraclinical/Dentistry disciplines, MBBS/BDS is the basic qualification for the post of Tutor; however, preference will be given to MD/MS/MDS degree in concerned discipline. For Tutor-cum-Statistician in Community Medicine M.Sc. (Statistics) degree is required.
- c. Candidates with MD/MS/MDS and Superspeciality degree are eligible to apply only in their concerned discipline (as per guidelines of MCI) as Tutor or Senior Resident.

- d. In case of non-availability of sufficient number of MBBS candidates, M.Sc. degree in Medical Anatomy/ Medical Physiology/ Medical Biochemistry/ Medical Pharmacology/ Medical Microbiology will be considered in respective discipline as prescribed by MCI.
- e. Qualifications as on the date of counseling shall be considered.
- f. If a candidate claims to possess any qualification equivalent to the prescribed qualification, the guiding rule/letter of authority must be furnished with the application form.

6. OTHER ELIGIBILITY CONDITIONS:

- a. The candidate must be a citizen of India.
- b. The Medical Graduates must have registered their Medical Qualification at Central/State Medical Council.
- c. The candidate must not be continuing or have completed the tenure as Senior Resident/Tutor in any MCI recognized Institute.
- d. The candidate whose service as SR/Tutor has been terminated by any govt. medical college in the state for whatsoever reason will not be considered for re-appointment.

APPLICATION FEE:

For each discipline applied for, a candidate is required to pay a non-refundable and non-adjustable fee of Rs.1000/(Rupees one thousand only) in shape of Demand Draft (signed at back by the candidate) to be drawn in favour of 'Principal, VSS Medical College, Burla' payable at 'SBI Burla (SBIN-0002034)'.

9. METHOD OF SELECTION

- a) The selection of candidates for recruitment to the posts will be made on the basis of career assessment i.e. MBBS/BDS/M.Sc. (60%), Intermediate (20%) and HSC or equivalent (20%);One mark will be deducted from the accrued career mark for each case of failure / extra attempt taken in any qualifying examination.
- b) The Selection Committee at their discretion may short-list the candidates to a reasonable number.
- c) Provisional Merit List will be published in website 'www.vimsar.ac.in' for the counseling as per date, time and venue notified above.
- d) The candidate has to appear personally at counseling for credential verification failing which, his/her claim will be forfeited.
- e) Candidate found eligible after document verification in a particular subject will be enlisted in a panel which will be duly approved by the selection committee.
- f) In case the appointed candidate to a post fails to join in time then only the next eligible candidate in the panel for the subject will be given a chance through a fresh counseling to be notified in the institute website.
- g) A candidate listed in the panel if fails to attend the counseling process will forfeit his/her claim to the post and his/her name will be deleted from the panel.
- h) Any vacancy over and above those advertised for may not be filled up from the list of empanelled candidates.

- i) Any subsequent counseling to select candidates from the panel will be a continuum of the previous counseling process.
- j) The panel will be valid for a period of one year from the date of approval (First Counseling) or till a period when the vacancy advertised are filled up or the panel is exhausted, whichever is earlier.
