

1. The appointment / engagement is purely temporary and on tenure basis for a period of one year which may be extended on year to year basis [by issue of an official extension order only] for a maximum period of three years subject to satisfactory performance appraisal report and eligibility in terms of age criteria [below 40years for SRs]
2. Any time during the tenure period upon receipt of any unsatisfactory performance report from the concerned HOD, the services of the concerned SR/Tutor will be terminated by the appointing authority; such decision shall be final and binding.

3. The appointing authority can terminate the tenure of SR/Tutor by serving a notice of 30 days without citing any reasons. The candidate can resign from the post with one month's notice to the authorities with reasons.
4. In case he/she is found to be absent unauthorised or submit resignation without a month's advance notice, he/she will not be issued experience certificate for his service in the institute and will forfeit one month's salary if direct candidate which he/she shall have to deposit as DD payable to Dean-VIMSAR before being relieved.
5. The in-service candidates [regular service under state government] are entitled for their usual salary and a monthly Incentive @ Rs.20, 000/- for Tutors having MD/MS degree, @Rs. 15000/- for Tutors having MBBS/BDS degree and @ Rs.10,000/- for Senior Residents. Direct candidates are entitled for a contractual monthly remuneration of Rs. 65000/- besides monthly incentive @Rs.5000/- for Tutors with MBBS / BDS degree. @ Rs. 10,000 for Tutors with higher degree and none for Senior Residents.
6. On appointment his /her service may be utilised as per need of the institute; however he/she shall be entitled for experience certificate as per his/her appointment order. Further, he/she may be posted any where depending upon the emergent needs of the State in the public interest.
7. Teaching experience of SR/Tutor shall be reckoned from the date of Joining in such post and the period of leave other than Casual leave availed by SR/Tutor will be compensated by repetition for in-service candidates only. In-service candidates shall be entitled for leave as per the rule in the original cadre. Direct candidates are allowed to avail casual leave for maximum 15 days a year not exceeding 10days at a stretch with prior approval only.
8. As soon as the tenure is completed he/she shall be relieved from the post.
9. Before the engagement all SR/Tutor will execute a bond on non-judicial stamp paper worth of Rs.100/- before the institution head that they will not club into litigation or resort to strike/cease of work or bargain for continuance beyond permissible tenure or indulge in any kind of private practice or engage with media or social media in controversial or sensitive matters relating to the institute without permission of the authorities.
10. The candidates are to submit the following documents at the time of their joining by reporting at the 'Office of Dean, VIMSAR'. Formats of the documents are attached with e-mailed order copy.

 - iii. Personal bio-data as per format prescribed
 - iv. Ten recent coloured passport size photographs signed at the back.
 - v. MCI Declaration form as Faculty for Non-clinical departments /as SR for clinical departments with relevant self-attested documents annexed [as per MCI-DF-2019-20 version].
 - vi. Copy of Govt. order of transfer to this institute [for candidates In-govt. of Odisha service].
 - vii. Relieve Order from the concerned authority under whom he / she was last working
 - viii. Bond as per format
11. Direct candidates are required to join **within seven days** of issue of this order, in service candidates are required to join **within seven days of issue of Govt. order of transfer**, failing which their claim to the post shall be forfeited.
